#### **ECONOMIC DEVELOPMENT UPDATES**

Kyle Zimbelman, Economic and Business Relations Manager, gave a brief update on the following:

- 1. The Economic Development update was presented to the Board of Supervisors on July 23, 2019. The Board approved the workplan with few changes;
- 2. He attended the Business Retention and Expansion Seminar on August 5, 2019;
- 3. He attended the Community Planning Project kickoff meeting held on August
- 7, 2019. The recruitment process is ongoing for the Community Advisory Group for the Shingle Springs component of the project;
- 4. Target submitted preliminary plans and pulled building permit;
- 5. The Economic Development Division sponsored and attended the Tri-Counties job fair with Golden Sierra Job Training held in Placer County on August 22, 2019:
- 6. The AMGEN Tour of California professional cycling race is considering a race start in El Dorado County for year 2020;
- 7. Valley Vision will give a presentation to the Board of Supervisors on September 17, 2019; and,
- 8. The County attended the El Dorado County Transportation Commission (EDCTC) General Plan outreach meeting on September 10, 2019.

#### **CEDAC MEMBER UPDATES**

Member Carlson updated the Committee on the following:

- 1. Rent cap was approved on September 11, 2019 by the State Legislature. The rent cap will last ten years, it excludes projects that are fifteen years old or less, and will cap rent increase at five percent a year; and,
- 2. The El Dorado County Democrats Townhall meeting will take place on October 13, 2019. They will be discussing affordable housing.

Member Wofford updated the Committee on the following:

- 1. Social media has enabled the harvest for Apple Hill Growers and El Dorado County Wine Association to make it's mark on visitors and has expanded their seasons;
- 2. The Agriculture Council has invited Fiona Ma to tour Apple Hill ranches on November 12, 2019, which she has accepted;
- 3. Apple Hill Farm to Fork and WINEderlust events were both very successful; and
- 4. Potential power outages by Pacific Gas and Electric and how it could affect the school district's.

Member Bernstein updated the Committee on the following:

- 1. Current Legislative work has consisted of worker rights. Currently waiting for a signature from Governor Newsome for the worker's rights initiative; and,
- 2. He is currently working on job killer studies.

Member Reinhardt updated the Committee on the development of the Folsom Ranch Area Plan. The new development will include ten thousand new homes and will include commercial elements. Grading is currently happening and in two years time the area will look completely different.

Member Johnston updated the Committee on the following:

- 1. Attended the third Tourism Mixer sponsored by Placerville Downtown Association on September 10, 2019;
- 2. Attended WINEderlust in downtown Placerville, which was very successful; and,
- 3. Georgetown Divide Fire Safe Council received a \$100,000 grant for fire fuel reduction in the Kelsey area. This will be a collaboration with Cal Fire and Department of Transportation. The California Conservation Corps has also agreed to help assist with clean up efforts in Kelsey.

Member Nisbet updated the Committee on the following:

- 1. In September, she attended Golden Sierra High School's career fair.
- 2. She attended the El Dorado County Chamber luncheon on September 11, 2019 and met Dr. Ed Manansala El Dorado County Superintendent of schools; and,
- 3. The 170th anniversary of Founder's Day will be held September 15, 2019 in Georgetown from 9:00 am to 4:00 pm.

Member Krakow updated the Committee on the following:

1. Continuing participation in El Dorado Hills Community Council, which meets on the first Monday of every month, where he gives Community and Economic Development Advisory Committee (CEDAC) updates on economic developments in the County;

- 2. Continuing participation with El Dorado Hills Chamber of Commerce as an ambassador; and,
- 3. His company has completed new office buildout.

Member Payne updated the Committee on the following:

- 1. He is on the Parks and Recreational Commission as the District III representative. Parks and Recreational Commission will be meeting September 19, 2019 at 3:00 pm to discuss recreational plans along the Missouri Flat corridor;
- 2. Parks and Recreational Commission has also assumed a new role by taking over the River Advisory Committee. They will be discussing the river management plan at the meeting on September 19, 2019. This new role will allow the Parks and Recreation Commission to expand opportunities in regards to the community service districts; and,
- 3. Member Payne founded the Patterson Ranch Fire Safe Council. He is still currently working on the Cal-Fire grant of \$526,000 and continuing to meet the responsibilities and requirements of the grant.
