**PROTOCOLS FOR PUBLIC COMMENT**

Except with the consent of the Board, individuals shall be allowed to speak to an item only once.

On December 5, 2017, the Board adopted the following protocol relative to public comment periods. The Board adopted minor revisions to the protocol on February 26, 2019, incorporated herein:

Time for public input will be provided at every Board of Supervisors meeting. Individuals will have three minutes to address the Board. During noticed public hearings, individuals authorized by organizations to speak to organizational positions may request additional time, up to five minutes.

Public comment on certain agenda items designated and approved by the Board may be treated differently within specific time limits per speaker or a limit on the total amount of time designated for public comment. It is the intent of the Board that quasi-jurisdictional matters have additional flexibility depending on the nature of the issue.

Individual Board members may ask clarifying questions but will not engage in substantive dialogue with persons providing input to the Board.

If a person providing input to the Board creates a disruption by refusing to follow Board guidelines, the Chair of the Board may take the following actions:

- Step 1. Request the person adhere to Board guidelines. If the person refuses, the Chair may turn off the speaker's microphone.
- Step 2. If the disruption continues, the Chair may order a recess of the Board meeting.
- Step 3. If the disruption continues, the Chair may order the removal of the person from the Board meeting.

**\$68,000: El Dorado County Fire (Search and Rescue 2020 Impacts)**

**\$5,800: Georgetown Fire (Rescue Equipment)**

**\$222,000: Lake Valley Fire District Request (Visitor Calls for Service 2020 Impacts)**

**\$350,000 (not to exceed): Lake Valley Fire District Request (Squad/Quick Attack fire apparatus) funding to be received after actual cost is determined**

Any amount in excess of \$5,000,000 use existing designated reserves to fund including:

**\$350,000 for staffing for Community Planning including Rural Centers**
