Commissioner Clavere provided advisement that Bylaws state that the Commission will have 10 regularly scheduled meetings annually and reminded Commissioners that in a typical year, there is no meeting scheduled in December.

Commissioners discussed the preference of skipping July or August and determined that the preference was to hold a regular meeting in July and skip August.

Paula Frantz clarified that Bylaws require that Commission have no less than 10 meetings annually, but it is not required that any meetings are skipped.

Commissioner Holman moved to hold a meeting in July and to skip the meeting in August; Supervisor Thomas provided the second.

6. [21-0993](#) Presentation of the Behavioral Health Budget and IDEA Consulting Assessment by Don Semon, Health and Human Services Agency Director, Nancy Callahan, Ph.D., and Nicole Ebrahimi-Nuyken, Behavioral Health Director (90 minutes)

Don Semon, Health and Human Services Agency Director presented an overview of the current Behavioral Health Division budget, budget challenges and revenue sources; highlighting high cost spent on inpatient and out of county residential care and need for step-down level of care options.

Nancy Callahan, Ph.D., IDEA Consulting presented an overview of the Final Report; emphasis placed on the disproportionate amount spent on inpatient services, the need for supportive housing in the community and need to build a functional outpatient system of care.

Nicole Ebrahimi-Nuyken, Behavioral Health Director presented the IDEA Consulting Recommendations; the report included 28 individual recommendations.

The Commissioners followed the presentation with questions and discussions focused on the IDEA Consulting report.

7. [21-0996](#) Review/Discussion/Questions of the Behavioral Health Director's Report (10 minutes)

Commissioner Clavere asked why the contract with Progress House was not renewed when they provide a large portion of services for SUDS clients.

Nicole Ebrahimi-Nuyken responded explaining that all of the details relating to the decision for non-renewal could not be discussed; but she reassured the Commission that securing new providers is in process.
