In addition to these services, the County is requesting Bickmore Risk Services provide an assessment of the current Risk Management Program and provide recommendations to help the county better manage its risks, reduce its potential losses and improve processes. This agreement is for a six (6) month period of time and not to exceed \$50,000.
