# **DEPARTMENT RECOMMENDATION**

Tahoe Youth and Family Services has provided services for the Probation Department since 2006. This amendment will increase the NTE amount to \$319,000, add the title "AOD Counselor", add crisis response to the scope of service, amend the per hour rate to now include AOD counselors, and add a weekly maximum hour cap. The term of the agreement remains unchanged at July 1, 2013 through June 30, 2016.

The proposed rate is within or below rates charged by similar service providers within the County.

# **DISCUSSION / BACKGROUND**

Tahoe Youth and Family Services provide "Program Therapist(s) or AOD Counselor(s)" for counseling, services and support to the Probation Department Juvenile Detention Facility in South Lake Tahoe. Counseling services will include individual and group counseling, family reunification services, Lifeskills, MRT, drug and alcohol counseling, anger management and crisis response.

In FY 2015/2016 HHSA- Mental Health Division notified Probation that they will be eliminating all services to the Probation Juvenile Detention facilities. Based on the ongoing need to provide service to this population of youth it has become necessary to increase the number of service hours and types of services that TYFS is providing.
