REASON FOR RECOMMENDATION: At the request of the Department of Agriculture and the Department of Transportation, the Procurement and Contracts division issued an Invitation to Bid for Herbicides. The Herbicides are for the maintenance and control of weeds.

The bid was inclusive of a large variety of different herbicides that may or may not be purchased during the awarded period. This will provide the departments with secured pricing for the awarded twenty-four (24) month period. The bid items listed on the spreadsheet were evaluated with estimated quantities. Additional herbicides not listed on the spreadsheet may be purchased at 10% off the manufacturers suggested retail pricing.

Ten (10) invitations to Bid were mailed, four (4) qualified responses were received, one from a local vendor.

FISCAL IMPACT/CHANGE TO NET COUNTY COST: Procurement and Contracts has been advised that funding is available within the Department of Agriculture and the Department of Transportation's budget.

ACTION TO BE TAKEN FOLLOWING APPROVAL: Following Board approval, the Procurement and Contracts division will issue a blanket purchase order in the amount of \$120,000.00 to Crop Production Services, Inc. of Fresno, CA.
