Department of Transportation recommending the Board adopt **Resolution 156-2011** sanctioning the closure of Main Street between Highway 193 and School Street, Harkness Street and Orleans Street between Church Street and South Street, and Placer Street between Church Street and Main Street, in Georgetown on Sunday, September 18, 2011, between 7:00 a.m. and 7:00 p.m. for the "Georgetown Founder's Day Event," subject to conditions set forth in Resolution No. 110-79 dated May 1, 1979, and subject to conditions set forth in the "Application for Road Closure." Fiscal Impact/Change to Net County Cost: No fiscal impact or net county cost.

Background: The "Georgetown Founder's Day Event" is an annual craft, food, parade and music fair, sponsored by the Georgetown Rotary Club. Requested road closures are for the safety of the participants, volunteers and spectators during the fair.

Reason for Recommendation: The Department of Transportation is recommending Board approval of the proposed Resolution for the safety and success of this community event. No involved agencies objected to this closure.
