The amount payable by the State to the County of El Dorado (County) under this Agreement is \$291,380 with no match requirement, however there is a County General Fund contribution of \$24,736 to this program to cover administrative costs that exceed the amount of the grant. This funding is included in the Department's FY 2010-11 Recommended Budget.

Reason for Recommendation:

Agreement MS-1011-35 provides \$291,380 in Federal and State funding to provide the Multipurpose Senior Services Program in the County of El Dorado during FY 2010-11. MSSP provides care management, which consists of providing information and assistance regarding appropriate community resources to meet needs, as well as monitor on-going care and health status. These services assist Medi-Cal eligible, frail, vulnerable seniors to remain in their homes and independent to the extent possible.

Action to be taken following Board approval:

Board Clerk to provide Human Services at Briw Road with three (3) certified resolutions, three (3) full copies and three (3) cover pages of Agreement MS-1011-35, two (2) Contractor/Vendor Confidentiality Statements and two (2) Contractor Certification Clauses (CCC307) signed by the Chair.

Human Services to distribute as appropriate and return one (1) fully executed copy of Agreement MS-1011-35 to the Board Clerk.
