### DISCUSSION / BACKGROUND

Federal funds through the U.S. Elections Administration Commission are available to assist the County, or reimburse the County for the future lease or purchase of California State approved voting systems in compliance with the requirements of Section 301 of the Help America Vote Act of 2002. The Department was recently notified of the availability of funds, and is requesting approval to sign the grant funding agreement.

This resolution is amending a clerical error in resolution 129-2016, specifying the correct agreement amount up to which the Recorder-Clerk-Registrar of Voters is authorized to execute. The State of California is requesting the correction.
