Reason for Recommendation

Pursuant to Board direction on Agenda Item No. 86, Legistar No. 13-0907, on June 10th, 2014, the Division negotiated terms for the addition of a Spay/Neuter Clinic (consisting of a preparation and surgery room) to the new Animal Shelter.

This Change Order No. 12 to Agreement for Construction Services No. 479-C1499 shall increase compensation by \$84,537.93, extend the completion date to September 29th, 2014, and expand the scope of work to include construction of an animal surgery center as related to work for the new Animal Shelter project
