**DISCUSSION / BACKGROUND**

The Surveyor's Office received an application from ASHA LLC, a Suspended California Limited Liability Company, for an Irrevocable Offer of Dedication for Road Right of Way (IOD) on Assessor's Parcel Number 119-080-017 and being more particularly described in Exhibit A and depicted on Exhibit B of the attached Exhibits. This offer of dedication is to remain in effect and run with the land until such time as the Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution and is in support of the Bass Lake Hills Specific Plan.

**ALTERNATIVES**

An alternative would be to not accept the IOD. By utilizing this alternative, the County or developers would be unable to meet improvement obligations of the Bass Lake Hills Specific Plan.
