Health and Human Services Agency oversees the local Foster Care and Adoption programs and helps place children into foster homes and arrange for the permanent adoption of children through collaboration with Lilliput Children's Services, Sierra Forever Families, Sierra Child and Family Services, and other private, non-profit adoption organizations. During the period October 1, 2015 through September 1, 2016, fifty four (54) children in El Dorado County were successfully placed into permanent homes and families through the adoption process.
