Background: Agreement 415-S0611 was approved by the Board on August 15, 2006 when the Revenue Recovery Division was assigned to the Treasurer/Tax Collector. The Department of Child Support-Revenue Recovery Division desires to continue to license software from Columbia Ultimate

which is critical to the continuation of the collection operations for El Dorado County. The Department manages the perpetual agreement with Columbia Ultimate for ongoing maintenance and support for equipment, software licensing, and collection services.

Reason for Recommendation: Continuation of the agreement is critical to the operation of the Department of Child Support Services-Revenue Recovery Division and successful collection of revenues for County departments.

Action to be taken following Board approval:

1. Procurement and Contracts shall encumber funds for the agreement.
2. Child Support Services shall continue to administer the agreement and process payments upon receipt and approval of invoices.
