Reason for Recommendation:

The Subdivision Improvements within West Valley Village, Unit 5B-1 have been completed according to the plans and specifications for this development, and per the conditions of the Agreement to Make Subdivision Improvements to Class I Subdivisions between the County and Meritage Homes of

California, Inc. (Owner), dated November 5, 2013 as amended.

Clerk of the Board Follow Up Actions

- 1) The Clerk of the Board will reduce the Performance Bond No. SU 1123642 to \$474,435 and advise the Owner it has been reduced.
- 2) The Clerk of the Board will hold the Laborers & Materialmens Bond No. SU 1123642 in the amount of \$2,372,170.64 for six months. If no claims have been filed, the Transportation Division will request in writing that the Clerk of the Board release said Bond.

Division Follow Up Actions

- 1) The Transportation Division will perform a one-year maintenance inspection and require owner to repair deficiencies noted (if any), in accordance with the terms of the Agreement.
- 2) The Transportation Division will submit a written request to the Clerk of the Board to release the respective bonds after the required time period, if listed conditions have been met.
