#### **DISCUSSION / BACKGROUND**

Mr. Bob Leone, the author of the book titled 'They Don't Cast Shadows" has chosen to film the screen version of his book in the County of El Dorado.

Mr. Leone's movie production company, Inspireworks LLC, will be filming at the Placerville Main Library, Placerville Juvenile Hall, and various locations in Cool and Shingle Springs. They have estimated the total filming time will last five weeks in the County with the Placerville Library and Juvenile Hall filming each requiring one day. Inspireworks will cover all County staff time and utilities involved with the motion picture filming.

Inspireworks use of County facilities provides a Public Benefit to businesses considering the amount
