DISCUSSION / BACKGROUND

The contract for the Montgomery Estates Area 3 Erosion Control Project (Project) was approved by the Board on June 2, 2015. Construction was substantially completed on August 20, 2015. Recordation of the Notice of Acceptance will start legal time frames for guarantees, a lien period and return of retention monies. Recordation of the Notice of Acceptance will also start the one-year time frame for releasing the Payment and Performance Bonds to the Surety.

Direct Construction Cost Summary:

Contract Item Cost	\$ 206,337.50
Contract Change Order Cost	\$ 8,116.00
Total Direct Construction Cost	\$ 214,453.50
Direct Construction Budget	\$ 260,000.00

Major Contract Change Orders on the Project dealt with the following:

- CCO #01 - Removal and replacement of existing water quality improvements (drainage inlet and rolled curb & gutter) to provide for better treatment of storm water runoff.

The costs listed are estimates. Transportation will be closing out the Project with the Contractor and finalizing costs over the coming weeks. Any significant deviations from the estimates above that exceed Transportation’s allocated authority will be brought back for the Board for review and approval in a subsequent agenda item.

FINANCIAL IMPACT

There is no Net County Cost associated with this item. Funding for the Project is budgeted in the adopted 2015 Capital Improvement Program and is provided by United States Forest Service Grants (97%) and a Tahoe Regional Planning Agency Water Quality Grant (3%). The anticipated direct construction cost is less than the direct construction budget established by the Board.
