Surveyor's Office recommending the Board adopt and authorize the Chair to sign Resolution **191-2020** for Abandonment of Easement 20-0007, to abandon a drainage easement on Lot 2 of Ridgeview West Unit No. 4, recorded in Book J of Subdivisions at Page 104, identified as Assessor's Parcel Number 120-700-002, within the community of El Dorado Hills, Supervisorial District 1.

**DISCUSSION / BACKGROUND**

A request has been submitted by Treviso Ridgeview 7, LLC, a California Limited Liability Company, owner of Assessor's Parcel Number 120-700-002, requesting that the County of El Dorado, Board of Supervisors, vacate a drainage easement located on said property. Subject easement is more particularly described in Exhibit A and depicted on Exhibit B of the attached Resolution.

The Drainage easement, as shown on Lot 2 of Ridgeview West Unit No. 4, recorded in Book J of Subdivisions at Page 104, was offered to the County of El Dorado by Ridgeview Homes West, LLC, A California Limited Liability Company, on November 19, 2007. The easement was acknowledged and Rejected by the County of El Dorado on January 8, 2008, and the Subdivision Map was recorded on January 17, 2008.

**ALTERNATIVES**

An alternative would be to not adopt a Resolution of Vacation for Abandonment of Easement 20-0007. By utilizing this alternative, the owner of Assessor's Parcel 120-700-002, would be unable to pursue any development that would impact subject easement.
