Fiscal Impact/Change to Net County Cost: No change.

The amount of federal and state grant funds payable by the State to El Dorado County under this Contract is \$1,209,729. This funding is included in the FY 2008/09 County Budget Request. Any County contribution to senior services is determined during the annual budget process.

Reason for Recommendation:

Contract AP-0809-29 provides \$1,209,729 in federal and state funding for provision of Older Americans Act and Older Californian's Act Title III/VII and Community Based Services Programs (CBSP) senior services during FY 2008/09. These services are designed to improve the lives of seniors age 60 and over residing in El Dorado County and to help them remain independent to the extent possible. The Contract, Contractor/Vendor Confidentiality Statement, Resolution and Blue Route are attached.

Action to be taken following Board approval:
