DEPARTMENT RECOMMENDATION

Surveyor's Office recommending the Board:

- 1) Acknowledge and approve an Irrevocable Offer of Dedication (IOD) for a public service easement on Assessor's Parcel Number 119-100-07 to remain in effect and run with the land until such time as the Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution.
- 2) Authorize the Chair to sign the *Consent to the Making of an Irrevocable Offer of Dedication for Public Service Easements* and to record the Irrevocable Offer of Dedication with the *Consent* attached. Authorization for recording said Offer is pursuant to Government Code Section 7050.

DISCUSSION / BACKGROUND

The Surveyor's Office received an application from El Dorado Hills County Water District, for a public service easement on Assessor's Parcel Number 119-100-07, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This IOD is in support of the Bass Lake Specific Plan.
