**Fiscal Impact/Change to Net County Cost:**

No fiscal impact or change to Net County Cost, the Probation Department has anticipated this revenue in their 2012-13 recommended budget.

**Background:**

Certain students on probation need additional support services to function in the public schools. County Schools is authorized under Chapter 605 of the Education Code, Section 1980 et seq. to enroll and provide for education of students through services provided by the El Dorado County Court

School Program.

County Schools to pay at a rate of one hundred dollars (\$100.00) per unit of average daily attendance as defined by Education Code Sections 46300 for each student who is within the provisions of 601 and/or 602 of the Welfare and Institution's Code, referred by County to County Schools, and enrolled in the Charter Community School Intervention Program.

Reason for Recommendation:

Per Agreement #048-O1311 total payment to County by County Schools for the 2012/13 school year shall be made by June 30, 2013; and for the 2013/14 school year shall be made by June 30, 2014. The term of this agreement is from July 1, 2012 through June 30, 2014.

The County Officer responsible for administering this agreement is Gregory S. Sly, Chief Probation Officer.

Action to be taken following Board approval:

- 1) Chair to sign Agreement 048-O1311
- 2) Board Clerk's Office to return two (2) executed agreements to the Probation Department to forward to County Schools.
