Fiscal Impact/Change to Net County Cost:

None. Marin County, as the State-designated MAA/TCM Host Entity, is entitled to receive an annual participation fee, which covers program administrative costs and is determined annually on a usage-based sliding scale. The annual MAA/TCM Participation Fee is estimated and budgeted at \$20,000 per fiscal year and will be paid from existing program revenues.

Reason for Recommendation:

El Dorado County participates in the federal Medi-Cal Administrative Activities/Targeted Case Management (MAA/TCM) Program. The California Department of Health Care Services (DHCS) administers the Program and requires that all counties contract with one "host" entity in order to participate in and receive revenues under the MAA/TCM Program. Marin County is the current designated Host Entity. The Department of Human Services acts as the El Dorado County liaison for receipt of MAA/TCM revenues. Agreement 063-M1211 is effective upon full execution for the term July 1, 2011 through June 30, 2013.

Action to be taken following Board approval:

Board Clerk to provide Human Services, at Briw Road, with:

- 1) Two (2) copies of Agreement 063-M1211 signed by the Chair.
- 2) Human Services to distribute as appropriate and return one fully executed Agreement to the Board Clerk.
