**DISCUSSION / BACKGROUND**

On December 5, 2017 (Item 9, File 17-1292), the Board adopted Resolution 177-2017 which provides for a total of four Members At-Large on the Community and Economic Development Advisory Committee (CEDAC), three of which are effectively vacant as of January 31, 2018. The Resolution demonstrates that Members At-Large serve four (4) year terms. The office of the Clerk of the Board posted Notices of Vacancy in August and December and received applications from six interested citizens, therefore the Clerk applied Board Policy I-5 to form a Committee Application Review Team (CART). The CART reviewed the six applications and conducted interviews with each applicant on January 18, 2018 to provide the Board with recommendations for appointment.
