Reason for Recommendation:

The Department of Transportation has received an Irrevocable Offer of Dedication for a drainage easement, situated along a portion of the back lot line, for the subject property identified as Assessor's Parcel Number 115-390-17, being more particularly described in Exhibit "A" and depicted
