3) Authorize the Purchasing Agent, or designee, to execute further documents relating to Agreement for Services 4889, including amendments which do not increase the maximum dollar amount or term of the Agreement, contingent upon approval by County Counsel and Risk Management.

# **FUNDING:** General Fund 100%. **DISCUSSION / BACKGROUND**

Since June of 2006, the Probation Department (Probation) has been contracting with AutoMon, LLC (AutoMon) for a proprietary case management system called Caseload Explorer, which includes modules for adult supervision, juvenile supervision, juvenile detention facilities, and fiscal; licensing; installation; maintenance; training; customization; and system upgrades.

Since the initial contract with AutoMon, Probation has added services to include product subscription and service of AutoMon's Ce Connect Licensed Software Products and Modules. These product systems allow for managing drug testing, providing flexible client reporting, and managing all phases of pretrial.

In 2015 a Request For Proposals was conducted to identify alternative providers of service. At that time it was determined that Automon continued to be the most cost effective means of providing case management services.
