**Reason for Recommendation:**

The Construction Contract for the Access Control/CCTV/Intrusion Alarm System for the Human Services/Child Support Services/Health Services Departments Placerville & South Lake Tahoe Project (Project) was approved by the Board on February 15, 2011. The Project was completed on June 17, 2011. Execution of the Notice of Acceptance will start legal time frames for guarantees and a lien period.

Major Contract Change Orders on this Project dealt with deletion of all work associated with the Health Services Department in South Lake Tahoe, utilization of Panasonic WV-NW502S 1.3 MP digital cameras instead of Arecont AV8185 2.0 MP digital cameras, and replacement of hardwired panic button systems with wireless panic button systems.
