Background: The US Department of Justice annually provides funds to reimburse the County of El Dorado Sheriff's Department to defray costs relating to the eradication and suppression of illicit marijuana. This agreement is retroactive as to term (1/1/10 - 12/31/10). The County did not receive

the Agreement from the Department of Justice DEA until 4/1/10.

Reason for Recommendation:

The is an annual agreement that the Sheriff's Office has participated in since 1997.

Action to be taken following Board approval: Original grant documents signed by the Sheriff have been returned to the Department of Justice. Upon approval, the funding will be added to the Sheriff's budget in the addenda process and utilized between July 1, 2010 and 12-31-2010.
