Background:

On November 1, 2011, at the request of the Probation Department, the Board of Supervisors entered into a contract with NMY & FS (Item #9) to provide for the mental health needs of minors (wards) housed for any period of time at Juvenile Hall pursuant to Title 15, California Code of Regulations, Standards for Juvenile Facilities. On October 30, 2012, at the request of the Probation Department, the Board of Supervisors signed the first amendment to Agreement 166-S1210 increasing the term by two additional years and changing the not to exceed amount to \$270,000.

This contract has allowed for the expansion of counseling services in the Juvenile Hall to supplement Mental Health Services in order to meet the mental health standards as cited above. The funding provided for this contract with a non-profit agency will allow the delivery of the equivalent of one Full Time Equivalent (FTE) licensed therapist, the same which could not be afforded if provided by a county agency.

Reason for Recommendation:

NMY & FS initially established a rate of \$40 per hour in the contract with anticipation of revenue offset through various agency funding sources. After analyzing actual costs over a one-year period, NMY & FS has identified service costs have significantly exceeded this rate. In addition, they determined other funding sources, including grants, cannot be utilized for services provided to Juvenile Hall clients. Without a rate increase to \$50 per hour, NMY & FS indicates it is likely they will not be able to continue providing services to the El Dorado County Juvenile Hall. An increase in the per hour rate of this agreement will ensure that NMY & FS is able to competitively provide the services to meet the mental health needs of minors (wards) through October 31, 2014.

Action to be taken following Board approval:

- 1. Chair to execute two (2) originals of the approved Amendment II to Agreement 166-S1210, and return one (1) original Amendment to the Probation Department
- 2. Probation Department shall distribute the document as appropriate.
