DISCUSSION / BACKGROUND

The 2023-24 Grand Jury published two Final Reports:

- 1) Case 24-06 - Voter Initiative Petitions: The People Need to be Heard, published May 13, 2024; and
- 2) Case 24-08 - Emergency Services Authority: Who Provides Oversight, published May 13, 2024.

Under the California Penal Code section 933 (c), the Board of Supervisors must provide a response to the Presiding Judge of the Superior Court within 90 days of the date that a Final Report is made available to the public. The response to the report is due by May 21, 2024, and the proposed response is therefore being submitted to your Board for approval.

The attached draft responses have been prepared in the form prescribed by Penal Code section 933.05 and addresses the findings and recommendations of the Grand Jury for which the Grand Jury requested a response from the Board of Supervisors.
