## **DISCUSSION / BACKGROUND**

The Surveyor's Office received an application from Shiva Nayeb and Ali Payravi, as wife and husband as community property with right of survivorship, for a grant deed and irrevocable offer of dedication for road right of way and public service easement (IOD) and a grant deed and irrevocable offer of dedication for a drainage easement (IOD), and a grant of temporary construction easement (TCE) on Assessor's Parcel Number 126-070-001, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. The IOD dedications are to remain in effect and run with the land until such time as the Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution. Said dedications are in support of the Malcolm Dixon Area of Benefit Public Road Improvements. The TCE shall be for a period of two years from the date of recordation of the document, or upon completion of the construction project, whichever shall occur first, at which time said easement will expire. Said grant is in support of the Malcolm Dixon Area of Benefit Public Road Improvements.

### **ALTERNATIVES**

An alternative would be to not accept the IODs and TCE. By utilizing this alternative, the County or developers would be unable to meet improvement obligations of the Malcolm Dixon Area of Benefit Public Road Improvements.
