DISCUSSION / BACKGROUND

The contract for the Patterson Drive and Missouri Flat Road Overlays Project was approved by the Board on June 28, 2016 (Item 36). The improvements were open to motorists on August 30, 2016.

Recordation of the Notice of Acceptance will start legal times for guarantees, a lien period, and return of retention monies. Recordation of the Notice of Acceptance will also start the one-year guarantee period for releasing the Payment and Performance Bonds to the Surety.

The costs listed are estimates. Transportation will be closing out the Project with the Contractor and finalizing costs over the coming weeks. Any significant deviations from the estimates above that exceed Transportation's allocated authority will be brought back for the Board for review and approval in a subsequent agenda item.
