DISCUSSION / BACKGROUND

The Surveyor's Office received an application from KFG & Four C's, LLC, a California Limited Liability Company, for an IOD (IOD 21-0004) for a Pedestrian Easement on Assessor's Parcel Number 120-690-011, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This dedication would provide for a Pedestrian Easement on Assessor's Parcel Number 120-690-011 located within the community of El Dorado Hills, Supervisorial District 1.

ALTERNATIVES

An alternative would be to not accept the IOD. By utilizing this alternative, no provision would be made for a Pedestrian Easement on Assessor's Parcel Number 120-690-011.
