DEPARTMENT RECOMMENDATION

Surveyor's Office recommending the Board:

- 1) Acknowledge and approve an Irrevocable Offer of Dedication (IOD) for a road right of way, including underlying fee, and a public service easement on Assessor's Parcel Number 119-100-12 to remain in effect and run with the land until such time as the Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution.
- 2) Authorize the Chair to sign the *Consent to the Making of an Irrevocable Offer of Dedication* for the Road Right of Way and Public Service Easement and to record the Irrevocable Offer of Dedication with the *Consent* attached. Authorization for recording said Offer is pursuant to Government Code Section 7050.

DISCUSSION / BACKGROUND

File #: 17-1164, Version: 1

The Surveyor's Office received an application from Janice Taylor as Trustee of the Janice Lynn Taylor Family Trust, for a road right of way, in fee, and a public service easement on Assessor's Parcel Number 119-100-12, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This IOD is in support of the Bass Lake Specific Plan.

ALTERNATIVES

An alternative would be to not accept the Irrevocable Offer of Dedication. By utilizing this alternative, the County or developers would be unable to meet improvement obligations of the Bass Lake Specific Plan.

OTHER DEPARTMENT / AGENCY INVOLVEMENT

The Department of Transportation has reviewed said IOD and supports the consent to the making of an Irrevocable Offer of Dedication.
