DEPARTMENT RECOMMENDATION

DISCUSSION / BACKGROUND

Surveyor's Office received an application from Stonehenge Springs, a Limited Liability Company, for an IOD (IOD 16-002) for a Road Right of Way Easement and a Public Utility Easement on Assessor's Parcel Number 054-402-18, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This dedication would provide for a future driveway encroachment from Assessor's Parcel Number 054-431-14 onto Faith Lane.

ALTERNATIVES

An alternative would be to not accept the IOD. By utilizing this alternative, no provision would be made for providing a possible future driveway encroachment from Assessor's Parcel Number 054-431-14 onto Faith Lane.

OTHER DEPARTMENT / AGENCY INVOLVEMENT

Community Development Agency, Transportation Division, has reviewed said IOD and supports the consent to and acceptance of this Offer, subject to the condition that said Road Right of Way Easement will not be County maintained unless and until it has been accepted into the County maintained road system by Resolution of the Board of Supervisors.

CAO RECOMMENDATION

It is recommended that the Board approve this item.
