DISCUSSION / BACKGROUND

Request to consider Planned Development PD16-0003/El Dorado Hills Memory Care (The Pavilions) submitted by Family Real Property for a Planned Development permit to allow the construction and operation of a 64-bed, single-story, 38,784 square-foot memory care facility. The project includes a maximum of 42 parking stalls (including 12 reserve stalls), landscaping, and three monument signs. The facility will be accessed from Francisco Drive and Cambria Way. The property, identified by Assessor's Parcel Number 124-140-33, consisting of 6.85 acres, is located on the southwest corner of Green Valley Road and Francisco Drive, in the El Dorado Hills area, Supervisorial District 1. (County Planner: Mel Pabalinas) (Mitigated Negative Declaration prepared)*
