**DEPARTMENT RECOMMENDATION:**

Timothy Amos Lee, doing business as El Dorado County Psychic, has made application for a business license as a psychic. After reviewing the itinerant business license application and the Sheriff's recommendation, the Treasurer/Tax Collector does not object to the issuance of the business license.

**DISCUSSION/BACKGROUND:**

Pursuant to El Dorado County Ordinance Code, Title 5, Section 5.14.070, Business Taxes, Licenses and Regulations, no license may be issued without the express authorization of the Board of Supervisors. Currently, there are three active business licenses for fortunetelling / psychic reading in the unincorporated areas of El Dorado County. The board may limit the number of licenses issued to such number as in its judgment will serve the public health, safety and welfare.

**ALTERNATIVES:**

The Board may decide not to authorize.

The Sheriff's Office recommends issuing the license. Applicant has submitted finger prints, cleared
