Title: Community Development Agency, Long Range Planning Division, recommending the Board approve

and authorize the Chair to sign an amendment to an Agreement for Services, and a corresponding amendment to an applicant funding agreement, to ensure the project applicant continues to fund all

costs, as follows:

1) Amendment III to Funding Agreement 241-F1311 with G3 Enterprises, Inc., increasing funding by

\$137,340 for a new total not-to-exceed amount of \$919,641;

2) Amendment IV to Agreement for Services 267-S1311 with ICF Jones and Stokes, Inc., increasing the maximum obligation by \$112,340 for a total not-to-exceed amount of \$575,421 to provide direct consultant services to the County for preparation of Environmental Impact Reports and planning consultation services for the Lime Rock Valley Specific Plan Project, and to extend the term expiration date by three (3) years; and

3) Approve and authorize the Chair to sign a Budget Transfer to increase revenue and appropriations

by \$137,340 associated with the Funding Agreement. (4/5 vote required)
