Reason for Recommendation

The state requires that each county's Social Services staff receive ongoing training to enhance technical skills, quality of case management, and excellence in service delivery. The Regents of the University of California, on behalf of its University of California Davis Extension campus, has developed Agreement for Services 034-S130 for the provision of high quality trainings for the County of El Dorado Health and Human Services Agency, Social Services Division (HHSA) during the period of July 1, 2012 through June 30, 2013 in the not to exceed amount of \$62,700.
