Background

In December 2008, the Sheriff's Office purchased a Reverse 911 system with Homeland Security Grant funds, and installed the system, to be used countywide, at the South Lake Tahoe Airport under the management of the City of South Lake Tahoe. Since that time, the No Host phone service that was being used, has undergone numerous breakdowns during emergency events. The need for service that is reliable and effective is critical to emergency management within the County. The Sheriff's Office researched and found that Cassidian Communication's hosted service is reliable and best meets our needs.

Reason for Recommendation

Approval of this Agreement will allow the Sheriff's Office to enter into an agreement with Cassidian Communications to provide reliable, hosted, online service for the countywide Reverse 911 system. However, due to the web based nature of the service, the Sheriff's Office accepts, and is alerting the Board of the non-standard warranty and limitation of liability language in the Agreement as provided by Cassidian Communications.

Action(s) to be taken following Board approval

Board Chair will sign, and Clerk of the Board will return fully executed agreement to the Sheriff's Office for processing through the Purchasing Department.
