- 4) Conditionally approve Design Review DR12-0002 based on the Findings and subject to the Conditions of Approval listed in Attachment 1; and

Background

Request to consider Rezone Z12-0001/Design Review DR12-0002/Skyview Apartments submitted by Gerald (Jerry) Caditz for the following: 1) Rezone from Professional Office Commercial-Design Community (CPO-DC) to Multifamily Residential-Design Community (RM-DC); and 2) Design Review application to construct four apartment units within one two-story building as an addition to an existing eight-unit complex. Forty-two percent of the total number of units are proposed to be

affordable to low and moderate income households. The property, identified by Assessor's Parcel Number 109-410-08, consisting of 1.03 acres, is located on the west side of Product Drive at the intersection with Market Court within the Barnett Business Park, in the Shingle Springs area, Supervisorial District 2. [Project Planner: Tom Dougherty] (Mitigated Negative Declaration prepared)

These applications were considered by the Planning Commission on October 25, 2012 and were recommended for approval (4-0). The minutes from this meeting are attached.
