Procurement and Contracts has been advised that funding is available within the Community Development Agency, Division of Transportation's budget. Non-General Fund: Road Discretionary and possible Federal Funds.

Reason for Recommendation

At the request of Community Development Agency, Division of Transportation, the Procurement and Contracts division issued an Invitation to Bid for the purchase of Plant Mix Asphalt Concrete for both the East and West Slopes of El Dorado County, to be used for County road maintenance and repair. Award for Category II of this bid has been cancelled at the request of the Community Development Agency, Division of Transportation and will be re-bid at a later date.
