procedure for the resolution of misunderstandings and disputes on the interpretation of a memorandum of understanding. An arbitrator is selected by the agreement of both the union and County from the list of arbitrators provided by the California State Conciliation and Mediation Services. The cost of the arbitrator is shared by the union and the County. This contract represents the County's share.

Reason for Recommendation

The arbitrator doing business as Golden Gate Dispute Resolution was agreed to by both the union and the County.
