Fiscal Impact/Change to Net County Cost

None. Veteran Affairs included a total of \$30,177 in revenue relative to these programs in their Fiscal Year 2013-2014 budget. As a result, approval of this recommendation will not impact Net County Cost.

Background

The California Department of Veteran Affairs administers the following three revenue programs:

- 1) The County Subvention Program which reimburses counties for a portion of their administrative costs and for workload unit performed;
- 2) The Medi-Cal Cost Avoidance Program, which reimburses counties for activities of County Veteran Service Office staff that result in savings to the Medi-Cal program;
- 3) The Veterans Service Office Fund, which is created through the sale of the Veterans license plates.
