Community Development Agency, Transportation Division, recommending the Board consider the following:

- 1) Authorize the Chair to sign the Notice of Acceptance with Herback General Engineering for the Montgomery Estates Area 2 Erosion Control Project, CIP No. 95170; and
- 2) Authorize the Clerk of the Board to release the Payment and Performance Bonds to the Surety upon notification from the Transportation Division after the one-year guarantee period.

FUNDING: United States Forest Service Grant Funds and Prop 84 Funds (Federal Funds).

Reason for Recommendation

The Contract for the Montgomery Estates Area 2 Erosion Control Project (Project) was awarded by the Board to Herback General Engineering on July 30, 2013. Construction started on August 27, 2013 and was completed on October 16, 2013. Board execution and subsequent recordation of the Notice of Acceptance will allow the Transportation Division to issue the proposed final estimate to the Surety, which begins the Project closeout. Recordation of the Notice of Acceptance will start legal time frames for guarantees, a lien period and return of retention monies. Recordation of the Notice of Acceptance will also start the one-year time frame for releasing the Payment and Performance

Bonds to the Surety.

The budget for direct construction and construction management costs for this Project, as reflected in the Transportation Division's 2013 Capital Improvement Program, was \$450,000 and \$175,100, respectively. The total available construction funding for the Project is \$375,000. The total available funding for construction management is \$175,100. The total available funding for contingency is \$100,000. The total direct construction cost of the Project is listed below:

- 3. One year after the recordation of the Notice of Acceptance, the Transportation Division will verify that all warranty work, if any, has been satisfactorily completed and will notify the Clerk of the Board in writing to release the Payment and Performance Bonds.
