### Background and Reason for Recommendation

On August 27, 2013, the Board approved Agreement No. 112-S1411 with IBM to provide hardware and software maintenance. In March 2014 the County purchased a new Mainframe (zBC12) with far

better technological capabilities compared to the old Mainframe (z9). Use of the new Mainframe requires a change in the pricing metric for usage billing purposes. AEWLC is a Sub-Capacity eligible pricing metric which provides additional price performance on a zBC12 Mainframe compared to EWLC on older generations of Mainframes such as the z9 Mainframe we replaced.

**Action to be taken following Board approval**

Following Board approval, Procurement & Contracts will process Supplemental Attachment 1 with IBM and submit to the Purchasing Agent for signature and distribution.
