Procurement and Contracts has been advised that funding is available within the Sheriff Department, Probation Department and the Health & Human Service Agency's budgets.

Reason for Recommendation

At the request of the Sheriff Department, Probation Department and Health & Human Services Agency, the Procurement and Contracts division issued an Invitation to Bid for Institutional Clothing, Bedding, and Toiletries needed for the two jails (Placerville and South Lake Tahoe), two Juvenile Treatment Facilities (Placerville and South Lake Tahoe) and the Psychiatric Health Facility in Placerville.

Nine (9) bid notification letters were mailed, none to local vendors. Four qualified responses were received, none from local vendors. The bid evaluation is based on actual usage of Clothing, Bedding and Toiletries over the last twenty four month (24-month) period.

Following Board approval, the Procurement and Contracts division will issue multiple blanket purchase orders in the total amount of \$125,000.00 to Bob Barker Company of Fuquay Farina, NC in the amount of \$85,000.00, Victory Supply, Inc. of Lexington, KY in the amount of \$25,000.00, Robinson Textiles of Gardena, CA in the amount of \$10,000.00 and to Pacific Care Products of San Francisco, CA in the amount of \$5,000.00.
