Background:

The County Surveyor's Office received an application from RUSSELL-PROMONTORY, LLC, A ILLINOIS LIMITED LIABILITY COMPANY, for an Irrevocable Offer of Dedication (IOD 14-006), for a drainage easement on Assessor's Parcel Number 124-070-37, and being more particularly described in Exhibit A and depicted on Exhibit B of the IOD (attachment A). The subject property is further identified as Parcel 6 of Parcel Maps Book 47, Page 107, as recorded at the Recorder's Office, El Dorado County.

Reason for Recommendation:
