Background:

The County Surveyor's Office received an application from Lennar Homes of California, Inc., a California Corporation, for an Irrevocable Offer of Dedication (IOD 14-005), for a drainage easement on Assessor's Parcel Number 118-650-20, and being more particularly described in Exhibit A and depicted on Exhibit B of the attached IOD. The subject property is further identified as Lot 98 of West Valley Village Lot 6&7 Unit 1, recorded in Subdivision, Book J at Page 124 at the Recorders Office, El Dorado County.

Reason For Recommendation:
