DISCUSSION BACKGROUND:

A request has been submitted by, Bill Martinelli, owner of APN 126-211-11, requesting that the County of El Dorado, Board of Supervisors, vacate the drainage easement located on the subject property. Said easement is more particularly described in Exhibit A, and depicted on Exhibit B of attached Resolution.

The drainage easement, as shown on Lot 2 of "PLAT OF GREEN VALLEY ACRES UNIT NO.1", recorded at Book C of Subdivisions at Page 72 was offered to the County of El Dorado by, RETIREMENT ACTIVITIES GROUP, A CORPORATION, on May 10, 1961. The easement was accepted by the County of El Dorado on May 22, 1961 and the Subdivision Map recorded on May 25, 1961.
