## **Background**

Request to consider Special Use Permit Special Use Permit S14-0011/Verizon Wireless Telecommunications Facility-Merrychase Drive submitted by VERIZON WIRELESS (Agent: Complete Wireless Consulting) to allow the construction and operation of a wireless telecommunication facility consisting of an 85-foot tall mono-oak pole with a maximum of eight panel antennas, an equipment shelter, and related ground equipment within a 31 foot x 34 foot lease area. The property, identified by Assessor's Parcel Number 082-421-05, consisting of 0.7 acre, is located north of U.S. Highway 50, approximately 574 feet west along Merrychase Drive from its intersection with Cambridge Road, in the Cameron Park area, Supervisorial District 2.
