DISCUSSION / BACKGROUND

The contract for the Pleasant Valley Road (SR 49)/Patterson Drive Intersection Signalization, CIP No. 53320 (Project), was approved by the Board of Supervisors (Board) on December 3, 2013 (reference Legistar Item 13-1011, version 1). The Project was opened to motorists in October 2014.

Recordation of the Notice of Acceptance will start legal time frames for guarantees, a lien period, and return of retention monies. Recordation of the Notice of Acceptance will start the one-year time frame for releasing the Payment and Performance Bonds to the Surety.

Summary of Costs

Original Bid:	\$1,747,742.02
Contract Item Cost:	\$1,800,000.00
Contract Change Order Cost:	\$275,000.00
Total Direct Construction Cost:	\$2,075,000.00
Direct Construction Budget:	\$2,267,245.00

Major contract change orders on the Project dealt with water pollution control and removing and replacing unsuitable material encountered in the roadway subgrade.

The costs listed are estimates. The Transportation Division (Transportation) will be closing out the Project with the Contractor and finalizing costs over the coming weeks. Any significant deviations from the estimates above that exceed Transportation's allocated authority will be brought back for the Board for review and approval in a subsequent agenda item.
